
#### 45 V, 100 mA PNP/PNP matched double transistor



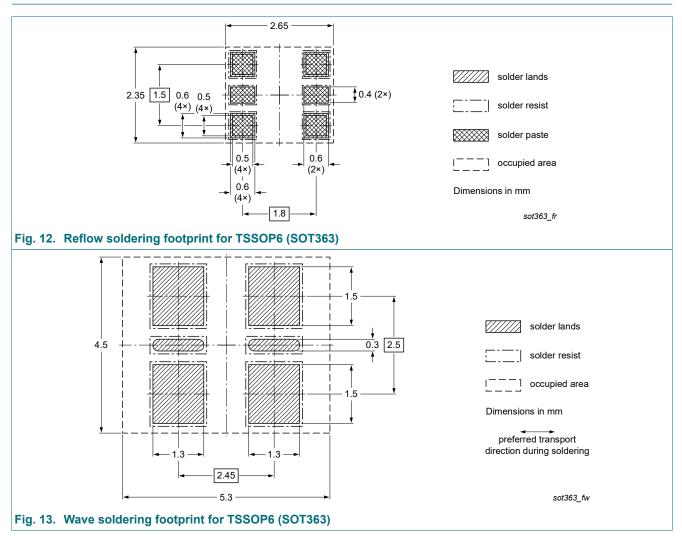
