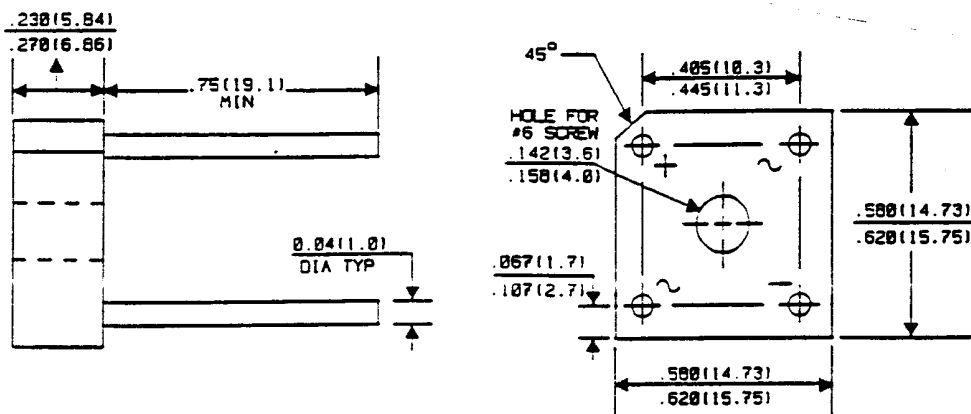

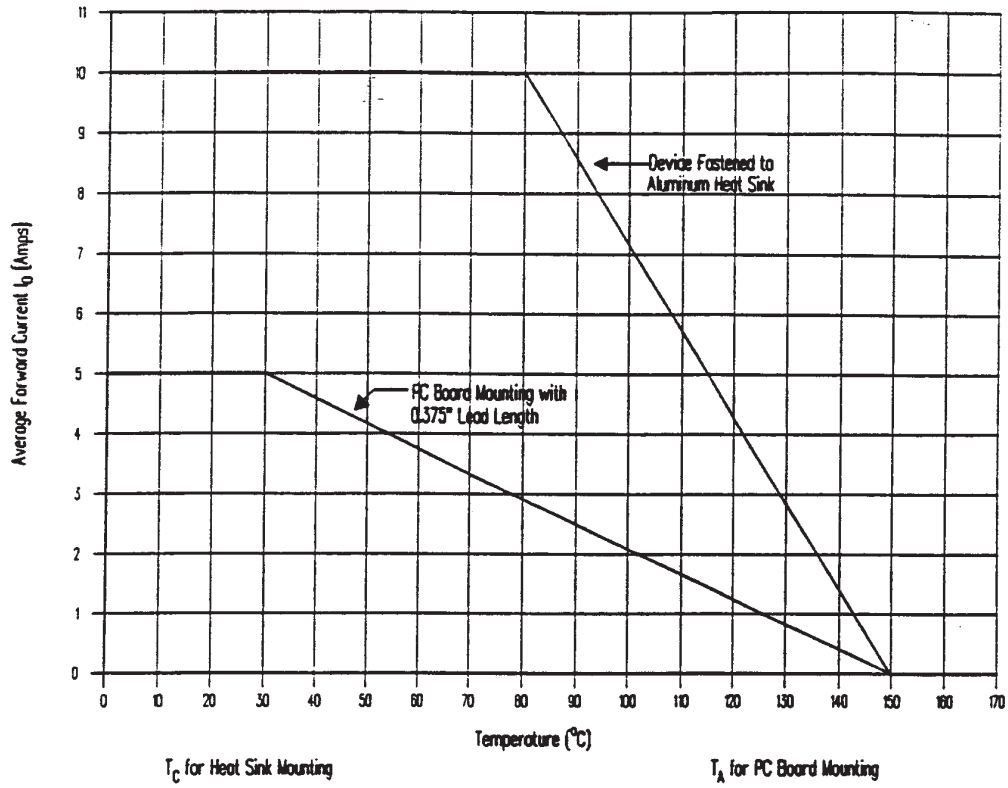

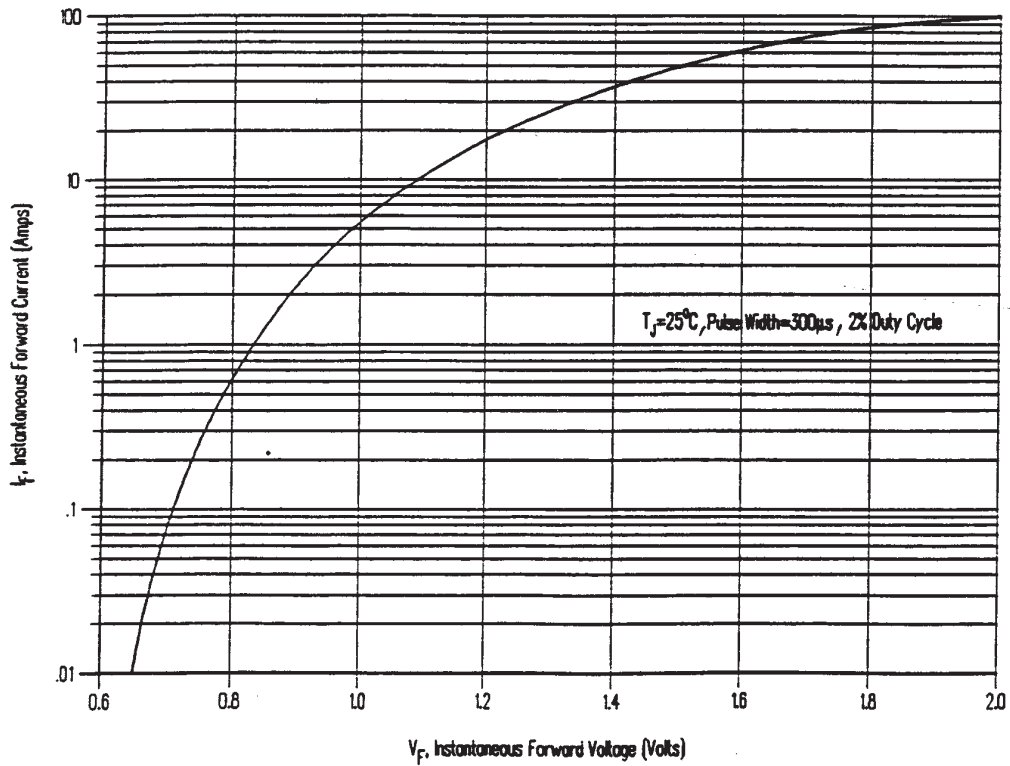
DIMENSIONS IN INCHES (mm).
