






SN54F02 . . . FK PACKAGE (TOP VIEW)



QUADRANT ASSIGNMENTS FOR PIN 1 ORIENTATION IN TAPE

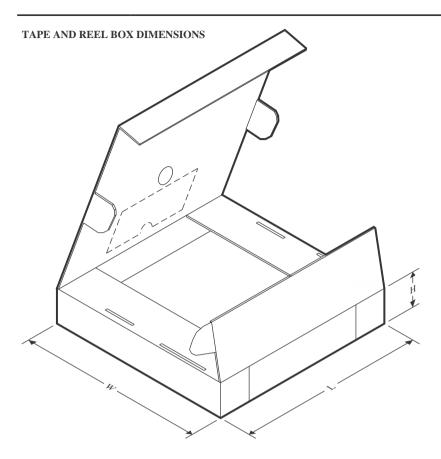
