


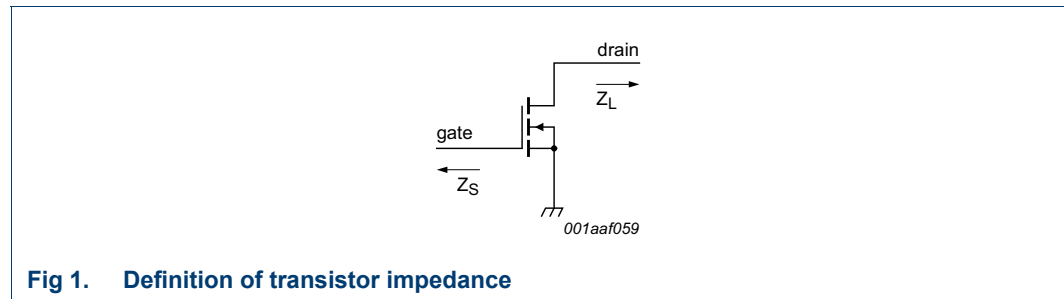


Fig 1. Definition of transistor impedance

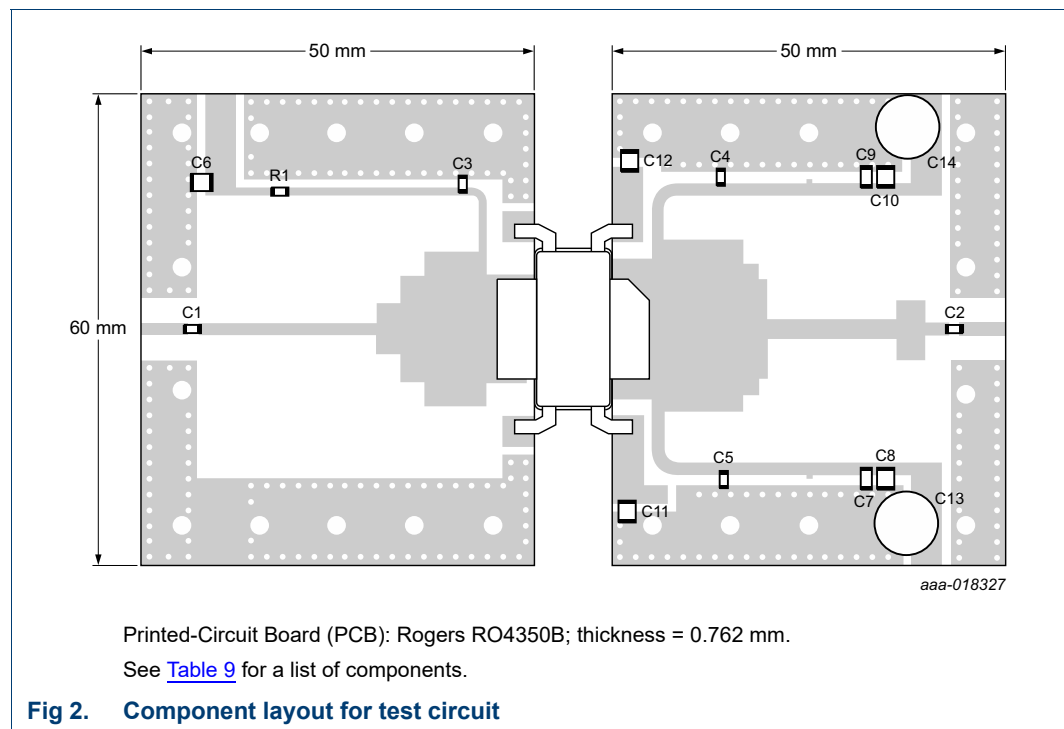


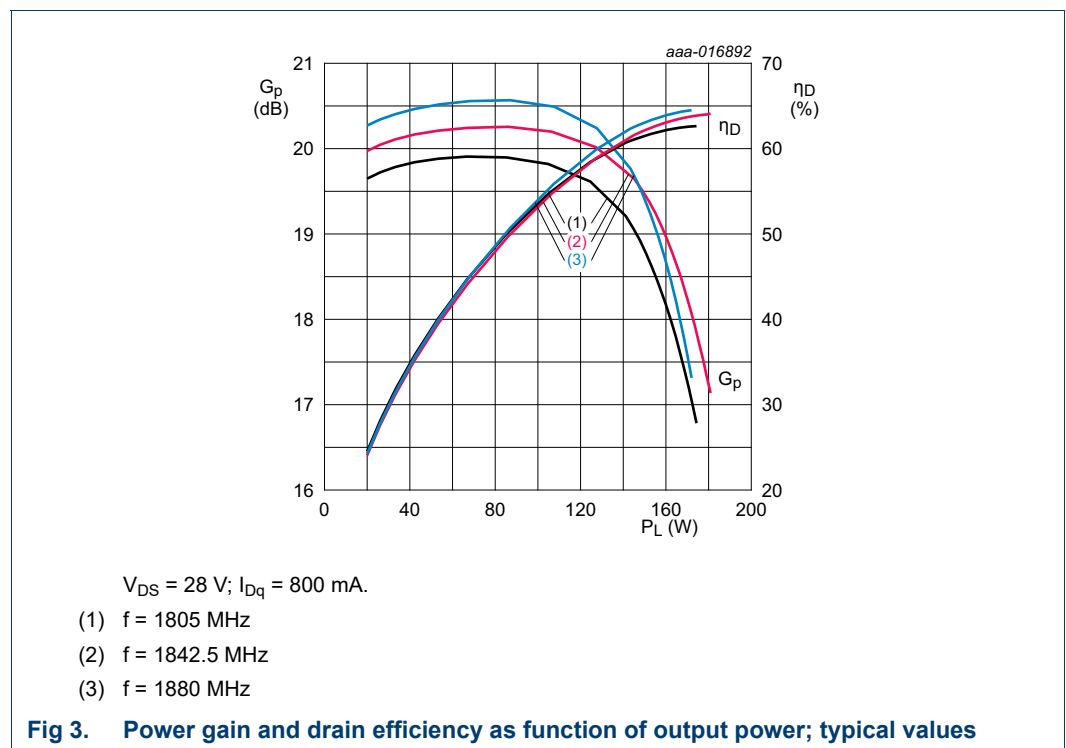
Fig 2. Component layout for test circuit

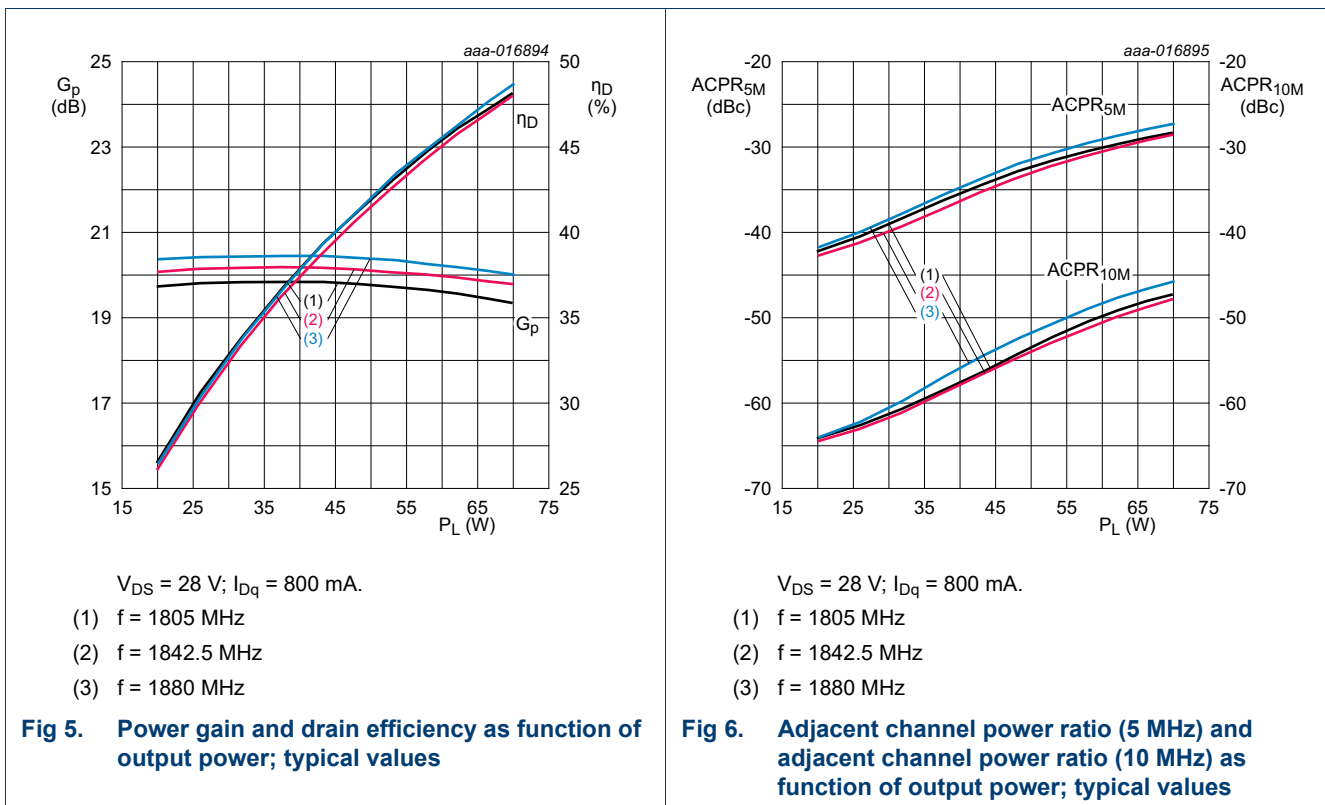

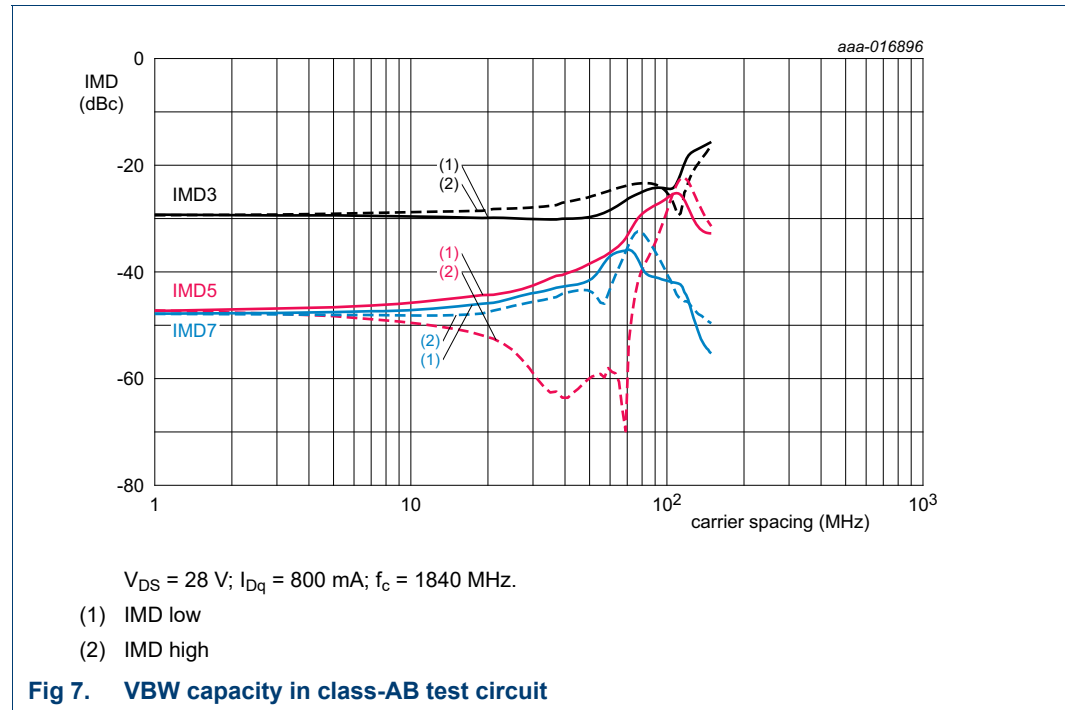

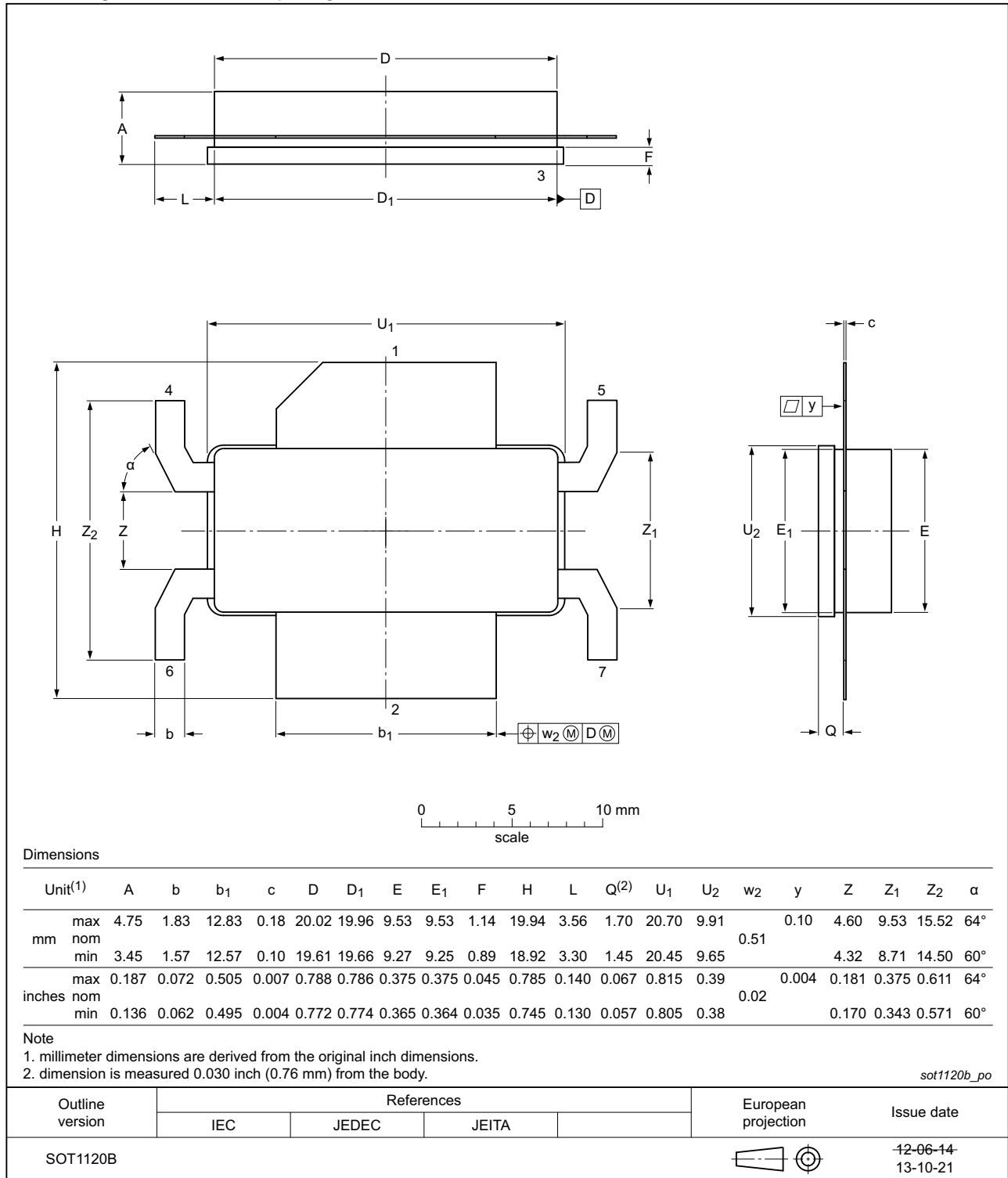



Fig 8. Package outline SOT1120B
