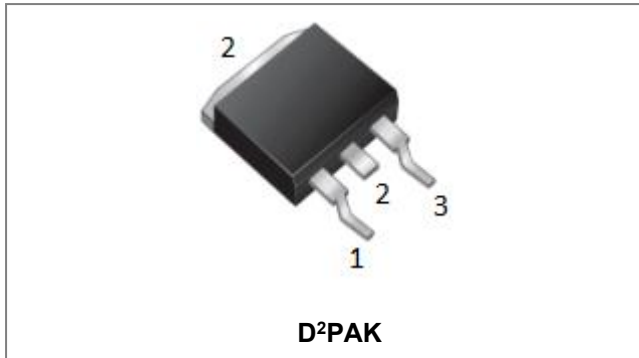


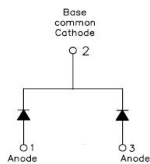

Typical Forward Characteristics

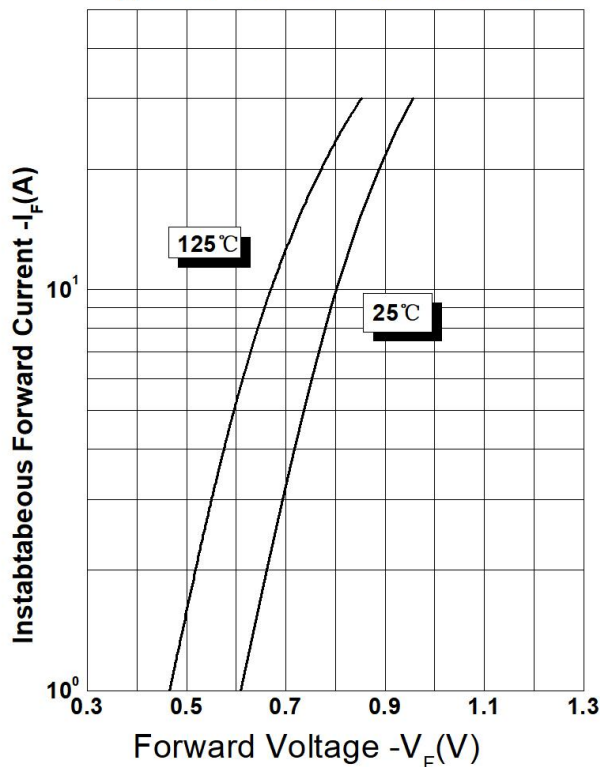

Typical Reverse Characteristics

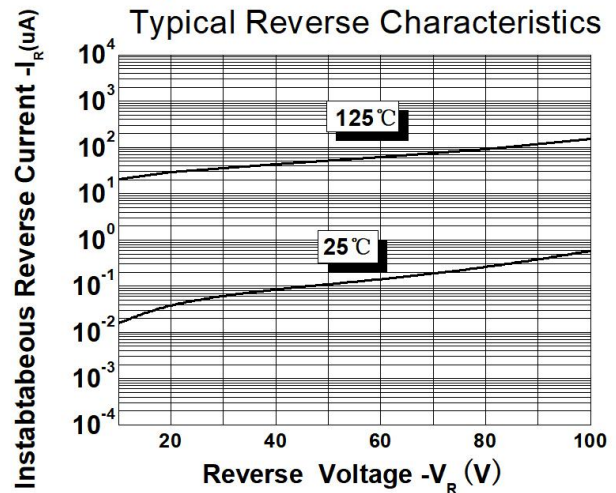
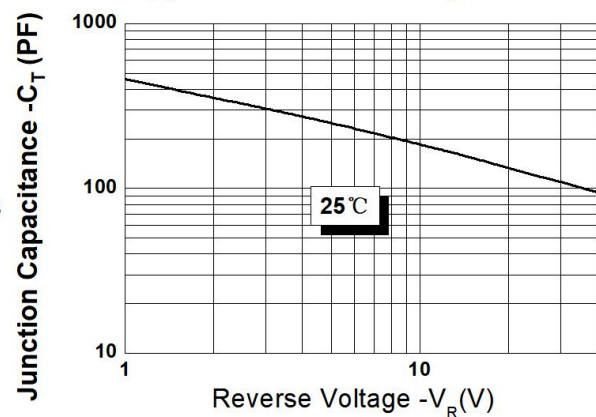
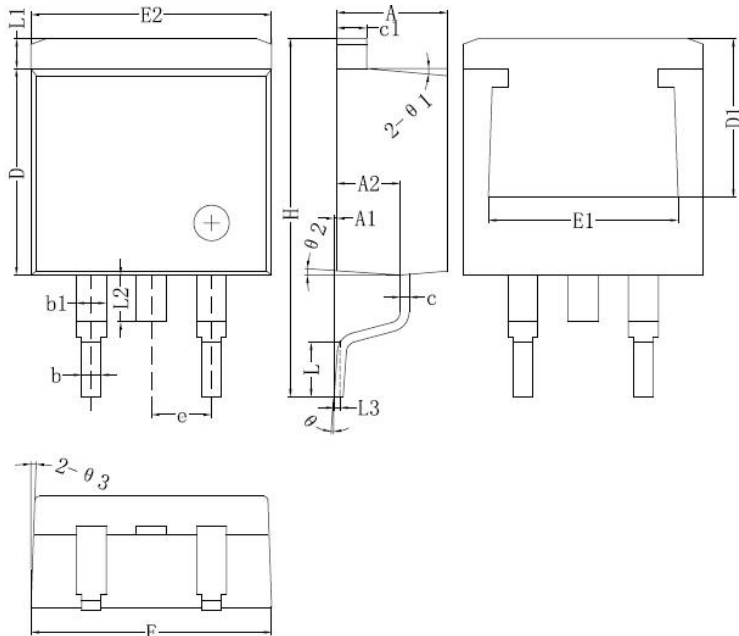

Typical Junction Capacitance



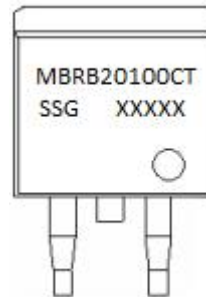

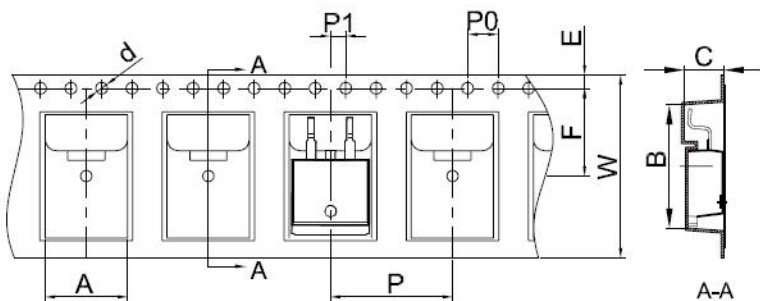
