**Derating Curve**



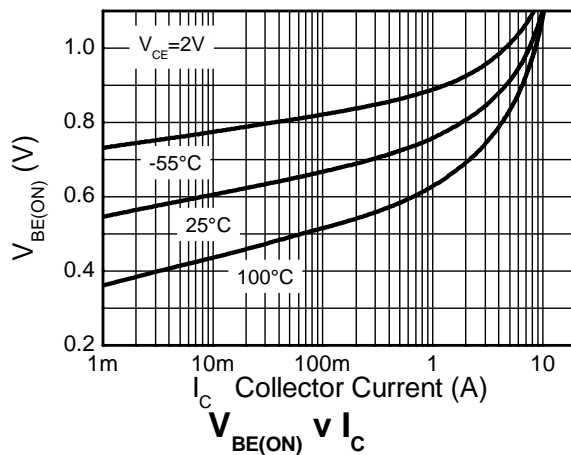
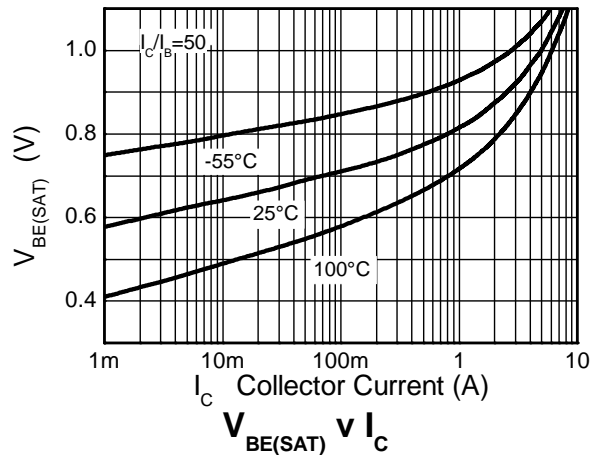
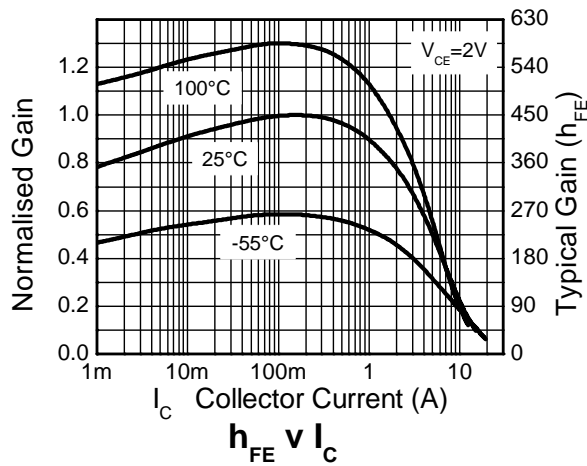
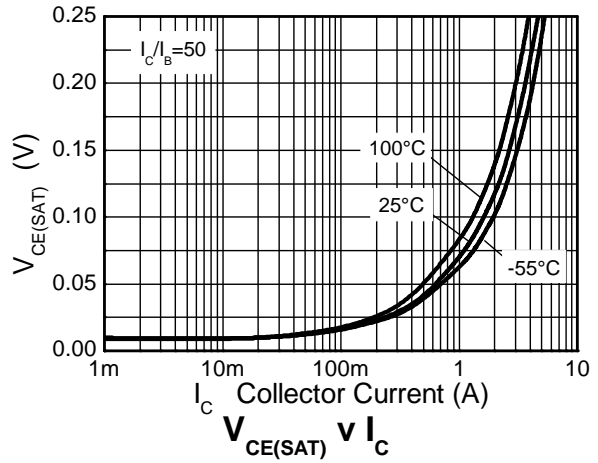
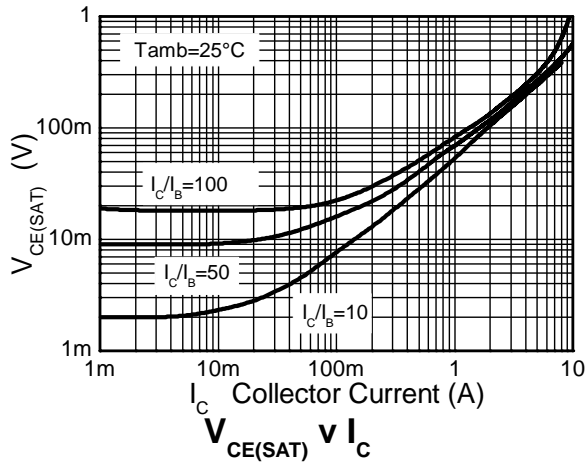

**Package Outline Dimensions**

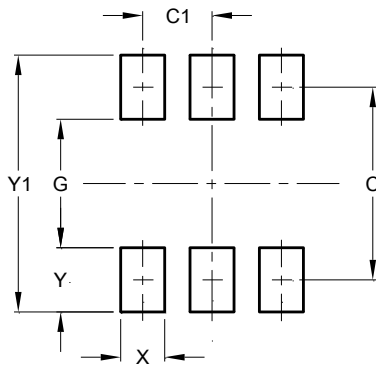
