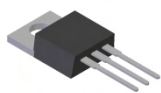

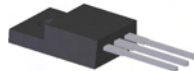

Top View



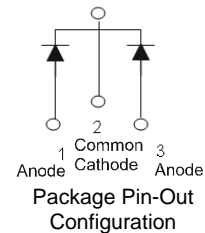
