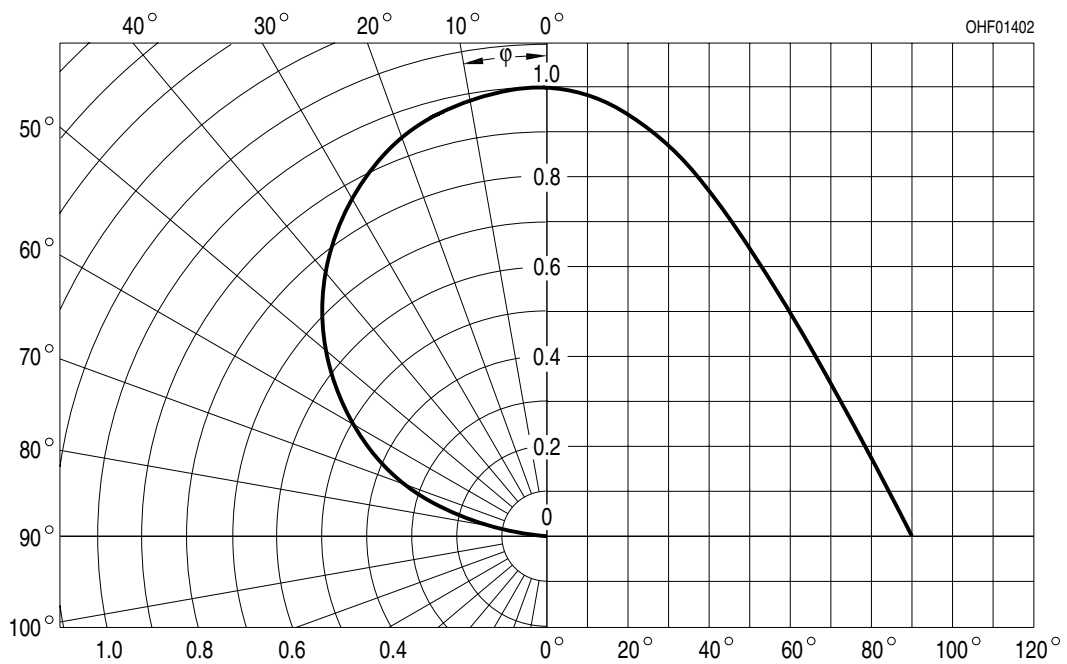

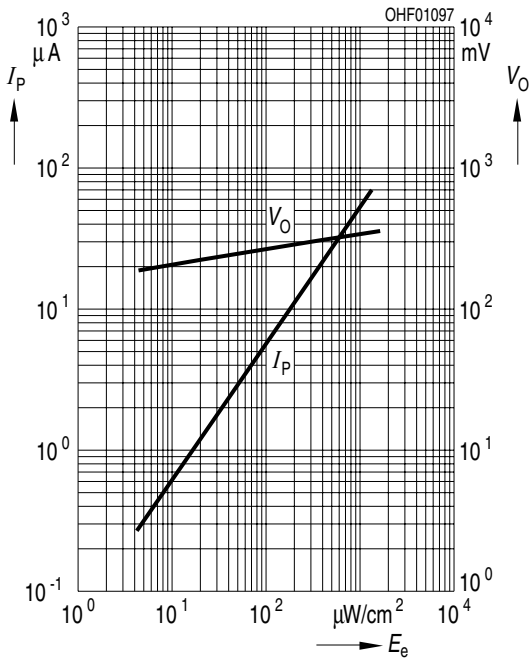

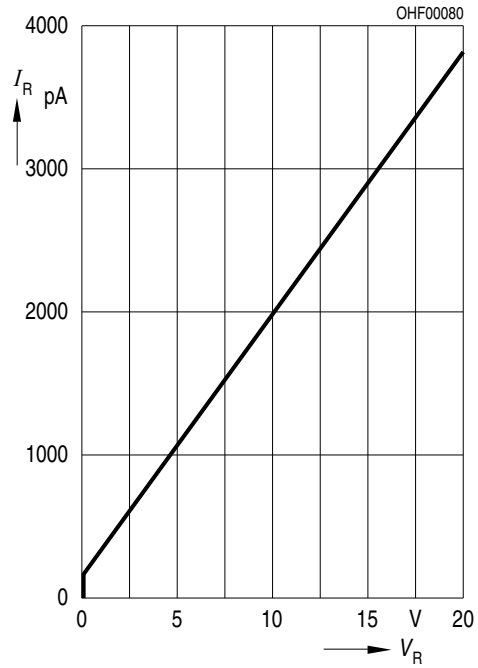

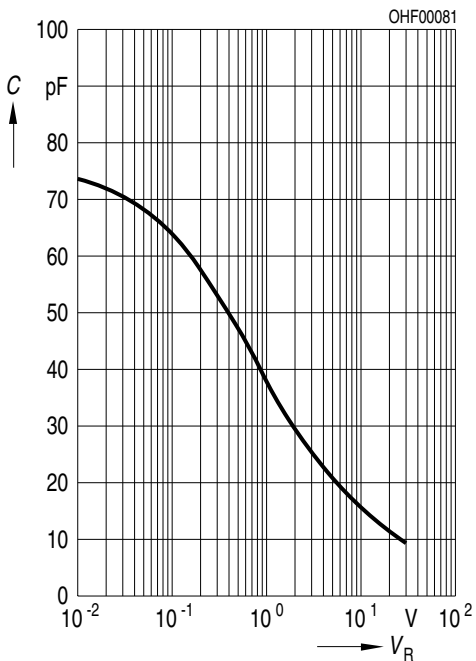

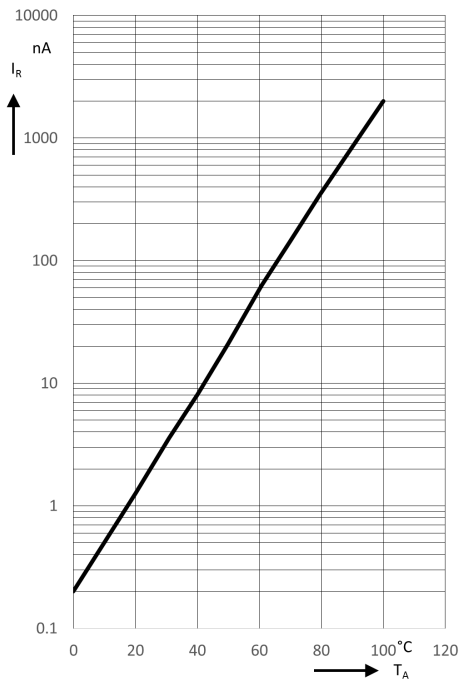

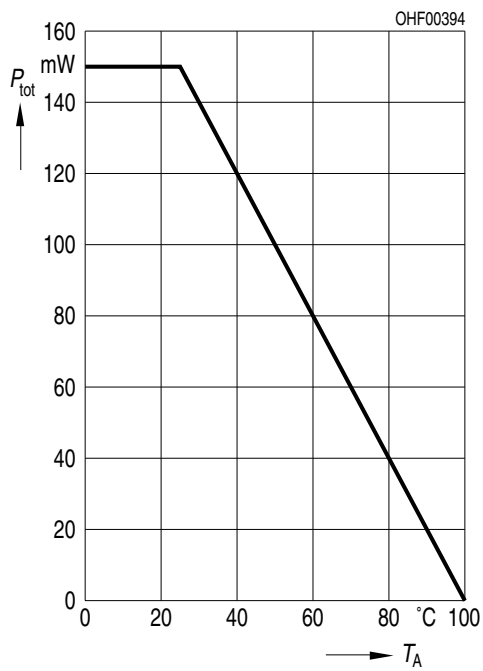
## Dark Current <sup>2)</sup>

$$I_R = f(T_A); E = 0; V_R = 10 \text{ V}$$



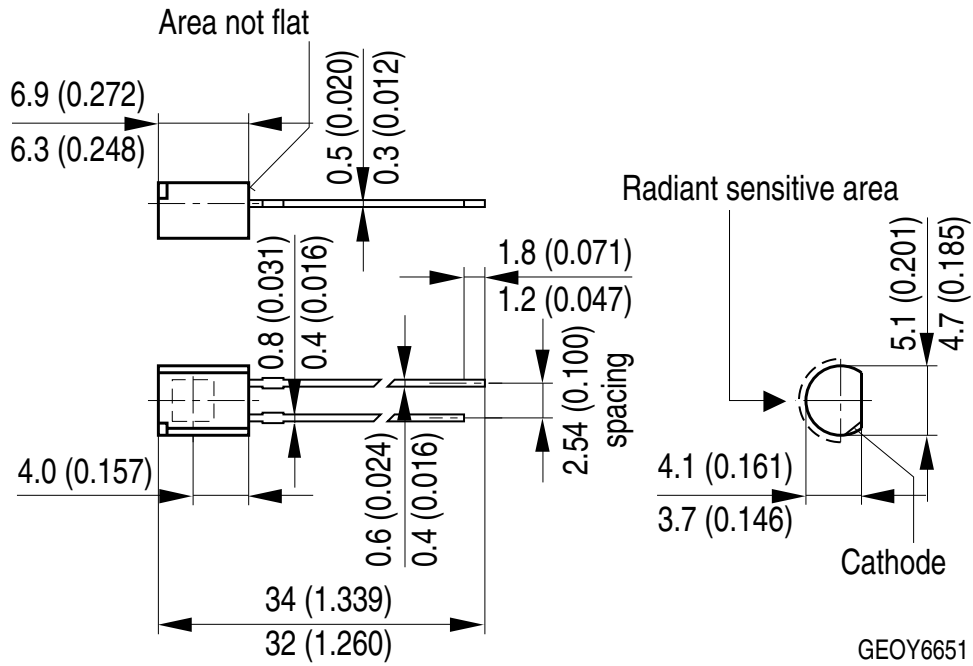
## Power Consumption

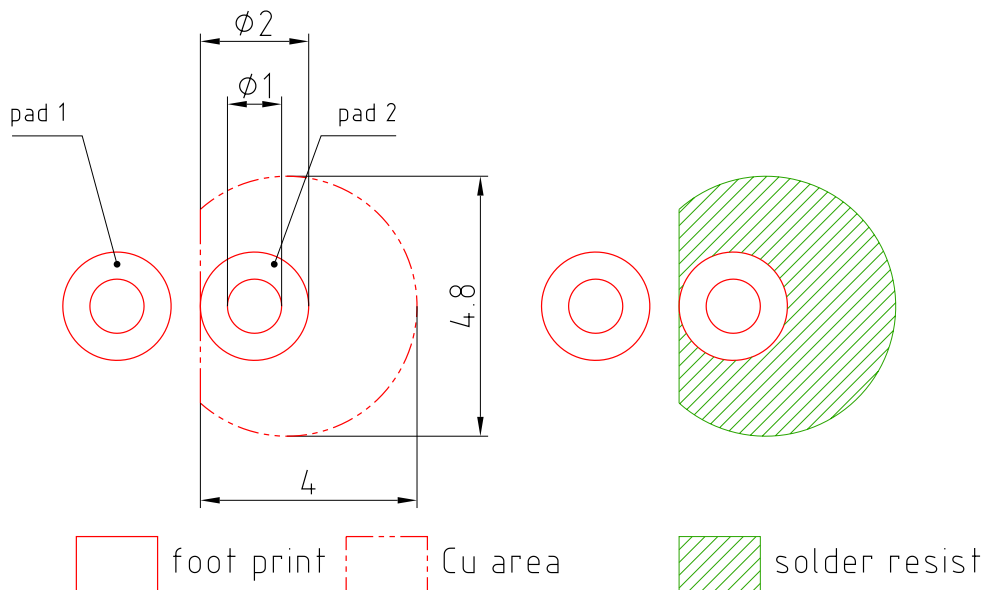

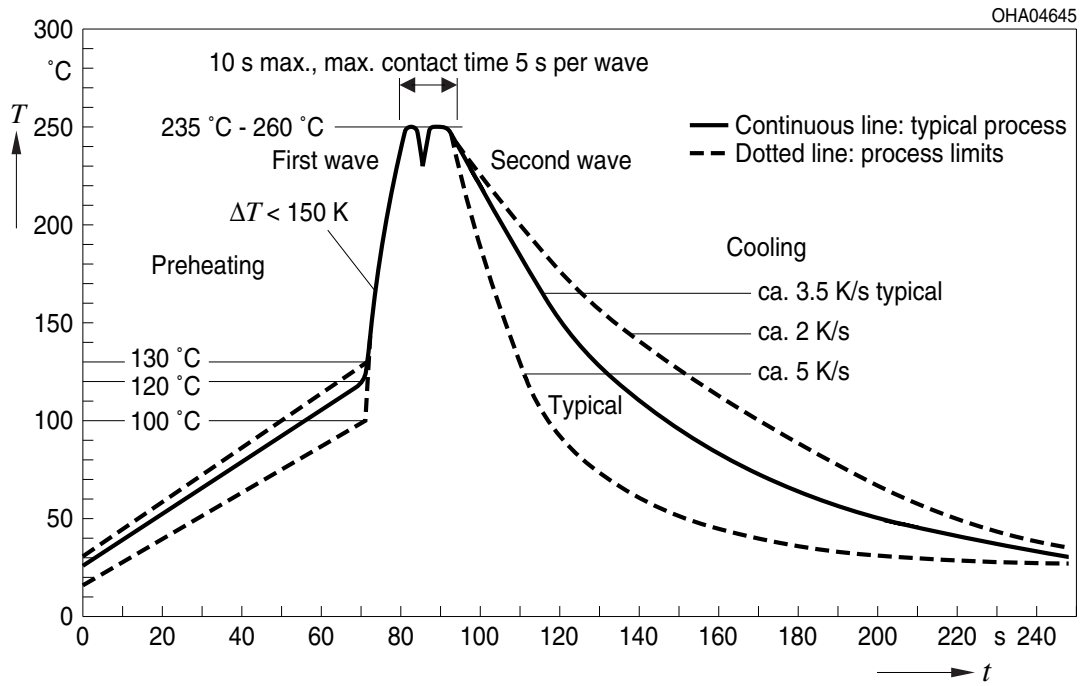
Pad 1: anode

## Notes
