






Figure 1. 8/20 μs Peak Pulse Current wave form acc. IEC 61000-4-5




Figure 2. Typical Capacitance C_{D} vs. Reverse Voltage V_{R}






Figure 3. Typical Forward Current I_F vs. Forward Voltage V_F




Figure 4. Typical Reverse Voltage V_R vs. Reverse Current I_R




Figure 5. Typical Clamping Voltage vs. Peak Pulse Current $I_{\mbox{\footnotesize{PP}}}$




Figure 6. Typical Clamping performance on + 8 kV - ESD events (Acc. IEC 61000-4-2)




Figure 7. Typical Clamping performance on - 8 kV - ESD events (Acc. IEC 61000-4-2)





Figure 8. Typical max. clamping voltage at ESD contact discharge (Acc. IEC 61000-4-2)




Application Note:

a) With the **VESD05A6C-HA3** 6 different signal or data lines can be clamped to ground. Due to the different clamping levels in forward and reverse direction the **VESD05A6C-HA3** clamping behavior is <u>Bi</u>directional and <u>Asymmetrical</u> (**BiAs**)



b) If symmetrical clamping behaviour is required the **VESD05A6C-HA3** can also be used as a <u>Bi</u>directional <u>Sy</u>mmetrical protection up to 5 lines. In this case pin no. 7 must not be connected.





