



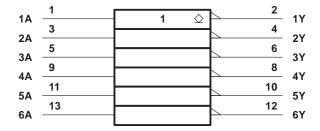


SN54ALS05A . . . FK PACKAGE (TOP VIEW)






