



The open-collector outputs require pullup resistors to perform correctly. These outputs may be connected to other open-collector outputs to implement active-low wired-OR or active-high wired-AND functions. Open-collector devices are often used to generate high V_{OH} levels.

The SN54ALS03B is characterized for operation over the full military temperature range of -55° C to 125°C. The SN74ALS03B is characterized for operation from 0°C to 70°C.






