





TYPICAL FORWARD CHARACTERISTIC PER LEG




I_F, instantaneous forward current (A)

FSM, peak forward surge current (A)


V_F, instantaneous forward voltage (V)

MAXIMUN FORWARD CURRENT DERATING CURVE




T_C, case temperature (°C)

TYPICAL JUNCTION CAPACITANCE PER LEG





