




Fig. 1 Turn-On Time




Fig. 2 Turn-Off Time




Fig.3 DC Current Gain




Fig.4 DC Current Gain




Fig.5 Collector-Emitter Saturation Voltage




Fig.6 Collector-Emitter Saturation Voltage




Fig.7 Base-Emitter Saturation Voltage




Fig.8 Base-Emitter Saturation Voltage




Fig.9 Base-Emitter Voltage




Fig.10 Collector Current




Fig.11 Input Capacitance




Fig.12 Output Capacitance





Fig.13 Power Derating Curve
