





TEST CIRCUIT 1 AVALANCHE CAPABILITY




TEST CIRCUIT 2 SWITCHING TIME









DRAIN TO SOURCE ON-STATE RESISTANCE vs. DRAIN CURRENT








PACKAGE DRAWING (Unit: mm)
