









 $I_{CE} = f(V_{CE}); I_{B} = Parameter$




Collector-Emitter Capacitance ^{2), 3)}



Collector-Base Capacitance ^{2), 3)}






Emitter-Base Capacitance ^{2), 3)}






Power Consumption

Dimensional Drawing 4)



Notes
